Notice: Members MUST be at least 18 years of age. No exceptions. If you plan to attend our trail rides you must have a LICENSED, INSPECTED, and INSURED vehicle with properly attached tow hooks, and proper tires for the parts of the trail that you wish to ride. Vehicles must be Jeep type or sport utility vehicles with a low range transfer case. Minimum tire size shall be 30". Maximum tire size shall be 38". All vehicles must have seat belts for ALL occupants which must be worn while vehicle is in motion. Tow hooks up front are mandatory and some type of tow hook or receiver hitch, clevis or other secure means of towing from the rear is required. A hitch ball is NOT acceptable for safe pulling of another vehicle. All non-hard top vehicles must have a roll bar. All vehicles must also have a first aid kit, a CB radio, fire extinguisher, tow strap with loops (no hooks) and a spare tire equal in size to the tires being run on the vehicle. No undersize or temporary spares will be allowed. We recommend that you also carry some tools, rags, hand cleaner, extra oil and fluids and possibly a change of clothing.

MEMBERSHIP fees for 2011 are \$50.00. This includes discounts with club sponsors, trail ride privileges, club events (not including any donation asked for at the trail ride or club events), monthly newsletter, and access to the private section of the Underground Jeeps forum. Membership expires on the last day of December.
